Old Canal Days-Heritage Village Location -- Vendor Rules

- 1. I understand that booth fees are 75.00 for a 10'x10" space and \$125.00 for a 20' x 20' space.
- 2. I fully understand that I am responsible to be in compliance with the Indian Arts and Crafts Act of 1990, which prohibits misrepresentation in marketing of Indian Arts and Crafts products within the United States. I understand that only items made in the Americas may be sold.
- 3. I will comply with all local, state and federal laws and regulations concerning fire, safety and health.
- 4. I understand that the Will County Historical Society, City of Lockport or Midwest SOARRING Foundation is not responsible for loss, theft or damage of items, or of injury to my employees, my customers or myself while on the premises of my assigned space(s). I understand there is no security provided, and I am responsible for the safety and well being of all my property and valuables.
- 5. Out of respect for Native values, I agree not to sell or display Native American artifacts obtained from archeological or Native gravesites, nor will I display or sell items that were used in religious ceremonies. I also agree not to display or sell any merchandise depicting alcohol, drugs or drug paraphernalia.
- 6. I understand that soliciting, advertising, and promoting for special non-profit programs will not be permitted.
- 7. I understand that NO refunds will be given, if I should cancel my plans to participate in Old Canal Days. I understand that I may not sublet my space to another vendor.
- 8. I understand that I am responsible for the cleanup and disposal of all debris in and 5 feet surrounding my designated vendor space. I understand that all my refuge must be taken with me.
- 9. I understand that pets/animals will NOT be allowed on the grounds during the event.
- 10. I understand that electric is not available, but if needed, I am responsible to bring my own generator.
- 11. I understand that the Will County Historical Society Staff and the MSF Staff will have final decision in all matters that may arise.
